- Nominee is to be recognized for his or her outstanding contribution to the ranching or feeding industries in Arizona.
- Nominee does not need to be actively producing or feeding cattle.
- Nominations **MUST** be submitted on this official form - typewritten, if possible. All supporting materials, including letters of recommendation, must be included or attached to this nomination form.
- Winner will be expected to attend the Awards Luncheon at the ACGA Summer Convention.
